Students with Life-Threatening Medical Conditions

UGDSB Policy 518: Students with Life-Threatening Medical Conditions, outlines the roles and responsibilities for all in the educational community to support students with possible life-threatening medical conditions. The prevalent medical conditions covered

under this policy are Asthma, Anaphylaxis, Diabetes and Epilepsy/Seizure Disorders. If your child has one of these, or any other life-threatening medical condition, please visit:

What to Send to School:

Please only send necessary personal items to school. Grade 1-6 Students are asked to bring the following items clearly labeled with their name:

- Backpack or tote bag for personal belongings
- Personal water bottle
- Seasonal outdoor wear
- Indoor shoes
- Personal school supplies that are necessary for the day (e.g., pencil case, calculator, etc.) Please note that each classroom educator will ensure families are aware of which personal school items are required.
- Toys and personal items should remain at home.

Kindergarten students are asked to bring the following items clearly labeled with their name:

- Appropriate-sized backpack or tote bag for personal belongings
- Change of clothing in a sealed bag
- Personal water bottle
- Seasonal outdoor wear
- Indoor shoes
- Toys and personal items should remain at home.

communication that needs to come to the office, please call 519-843-2665. Parents/Caregivers please remind your child to check into the office before going to the classroom.


Occupational Therapy Support at John Black

Occupational Therapist (OT) from KidsAbility Centre for Child Development will be working with students and teachers in our school. A letter will be sent home to provide an overview of their services.

BYOD - Bring your own device

Notifying the School of a Student Absence – Safe Arrival

The rules of the Safe Arrival program state that the school must know why a student is not present on any particular day. This means that school office staff will continue to try to contact parents until one is reached; we sometimes make four or five calls for one child. This takes an inordinate amount of time and often stretches the office staffs' ability to carry out other duties. Please assist us in speeding this process up and calling when you know if your child(ren) is/are going to be late or absent. Messages can be left by phoning the school (519 843-2665) and choosing extension 100. We prefer that messages are left as our morning entry time is very busy. Please send any notes or information about absences to your child's teacher if you are aware in advance and we will make sure it is noted. Thank you!

Arrive Home Safely and Timely

After being dismissed from class at the end of the day, students are requested to go directly home or to a caregiver before proceeding to other activities. This includes playing after school on the playground. Please reinforce this message with your child.

Student Safety on Lamond St.



As you may have noticed, we have a visual and physical barrier creating a walking pathway for our students. This has helped to highly improve the safety on Lamond St. All students with bikes/scooters are to walk their vehicles within this path coming to and from school. To ensure the utmost safety, we ask that parents/guardians drive slowly on Lamond St. during drop-off

and pick-up times.

Lunch Time

Students are expected to stay at school during the lunch hour unless going home with a parent. We do not encourage students leaving the property without an adult.

Allergies Many students suffer from allergies. Reactions to allergic substances vary from relatively mild irritations such as itchy eyes, sneezing, scratchy throat, etc. to potentially fatal conditions where the sufferer experiences breathing problems and/or anaphylactic



shock. A student who is allergic to peanuts often falls in this second category. Please be



aware that there may be restrictions in your child's class to protect a student with such an allergy. We ask you to abide by any restriction(s) that may be imposed in these cases and, in the case of nuts or nut products,

we ask that you do not send any to school. We are a nut-free school. Parents of students with potentially life-threatening allergies are asked to inform the school and complete the required paperwork. Thank you for your cooperation and understanding as we work together to keep our students safe.

Bus Riding Expectations

Students are expected to follow the rules of the bus by listening to the driver, remaining in their seats, refraining from eating or drinking anything while on the bus, and following the directions of the bus patrols when entering or exiting the bus. A newsletter has been sent home from the bus company along with their expectations for student behaviour. It is very helpful when parents review these rules with their children at home. Thank you for your partnership in keeping our students safe.



Bus Reminder

Bus transportation is provided to students based on the distance their home is from the school. Such students are placed on a regularly scheduled bus route and must travel

on this route and no other. Bus students may not switch buses for any reason. In addition, students who walk to school may not travel on a regularly scheduled bus route. Courtesy seating is available this year depending on the number of seats available. Parents/Guardians need to fill in the courtesy seat form online, found on www.stwdsts.ca under Communications, Forms, TF006. Courtesy seats become available in early October. Transportation to and from school, for students who qualify under school board policy, is provided by Wellington-Dufferin Student Transportation Services/Services de transport de Wellington-Dufferin (STWDSTS).

Reminder for parents/guardians: Accidents happen – be prepared with Student Accident Insurance

Parents and guardians are responsible for expenses related to student injuries on school premises or during school activities. Accidents can and do happen and the costs involved might not be fully covered by Provincial health care or employer group insurance plans.

The Upper Grand District School board is empowered under *The Education Act* to offer Accident and Life Insurance for students.

A letter from the Upper Grand District School Board will be sent home with students containing information with respect to two Programs available for the purchase of Student Accident Insurance. The Insuremykids Program is offered through Old Republic Insurance Company of Canada and the Studyinsured Program is underwritten by Certain Lloyds's Underwriters through AON Insurance.

Each program offers a variety of options, including family rates at affordable prices. The cost must be paid by the parent or guardian. Paper copies of the application are no longer available. Purchase is done directly online or by contacting the Provider:

Professional Activity Day Description 2023/24

Date: September 18, 2023

Length: Full Day

Topic 1: AM - Literacy

Entity Hosting: School board

Presenter(s)/Facilitator(s): School Administrators

Description: Kindergarten to Grade 3 teachers will receive professional learning on early reading instruction, universal design for learning, and screening. to ensure educators are prepared to support their students in a manner consistent with the recommendations in the <u>Ontario Human Rights Commission's</u> *Right to Read* report for the full school year. Additionally, staff will focus on the implementation of the new Language curriculum in grades 1 - 8 and on embedding high yield strategies in reading across the various subject curriculum areas. In Secondary schools, teachers will continue professional development on the de-streamed grade 9 course and on effective practices for teaching reading across various subject areas. Furthermore, enhancing teacher efficacy in supporting students to consolidate foundation knowledge and skills in Grade 9 destreamed English will be a focus of this professional learning time.

Topic 2: PM - Student Well-being, School Safety and Violence Prevention

Entity Hosting: School board

Presenter(s)/Facilitator(s): School Administrators and Online Learning Platforms

All staff will receive training related to *PPM 161 - Supporting Students with Prevalent Medical Conditions*. Additionally, educators will engage in continued learning regarding detection and intervention of sex trafficking related to students. Finally, staff will review procedures and policies regarding school safety and violence prevention including but not limited to emergency response, child abuse and protection, student crisis response protocols and suicide intervention.

September 5, 2023 UGDSB Threat/Risk Assessment and Suicide Protocol

Notification Dear Parents/Guardians:

The Upper Grand District School Board is committed to providing safe learning environments for all students, staff, school visitors, and community members. When safety is threatened by the potentially violent or dangerous behaviour of a student, which places either the student or others at risk, school staff follow specific protocols for the protection of all. It is important that you and your child(ren) are aware of these protocols as, in times of imminent risk, they will be followed and might include, a) the immediate involvement of emergency services or supports and, b) sharing of private information.

Community Violent Threat Risk Assessment Protocol (VTRA): This is a community-wide protocol that details the steps by which school staff quickly respond to threatening incidents such as: possession of a weapon or replica, bomb threat or plan, verbal, written, or electronic (internet) threats to injure or kill oneself or others, or other threats of violence. The first step involves gathering the principal/vice principal, social worker, psychological consultant and/or child and youth counsellor and police to assess the immediate threat. If the situation is deemed one of imminent risk, the superintendent is informed and community agencies that are part of the VTRA protocol, such as local mental health organizations, are consulted. Suicide Prevention, Intervention and Postvention Protocol: This protocol details the steps by which school staff respond to a student at risk of suicide. The protocol details steps for responding quickly, sensitively, and effectively to ensure the student's safety. The steps include having a trained staff member interview the student and taking the necessary steps to ensure safety and arrange appropriate support for the student. Contact with parents and or guardians: Parents and guardians play a vital role in maintaining the safety and well-being of their children. When a student is involved in a VTRA or a suicide risk or threat, every effort will be made to contact parents/guardians unless circumstances prevent us from doing so. If parents/guardians cannot be reached, or if they choose not to provide consent but a safety risk still exists, the processes outlined in the VTRA Protocol or Suicide Intervention and Postvention Protocol will still be followed.

Elementary School Organizations

Schools have built class lists based on their tentative organizations. Changes may be necessary at your child(ren)'s school in order that our Board remains compliant with Ministry parameters (see below). Any changes would be implemented by Monday, September 18th. Principals do not have the option of changing the school organization that is set by the District Staffing Committee of the Board. If changes affect your child(ren), you will be informed by the school.

Ministry of Education Parameters

- Full Day Kindergarten Class Size Average for the Board is 26 students
- 90% of Full Day Kindergarten classes with 29 or fewer students
- 10% of Full Day Kindergarten classes with up to 32 students, under certain circumstances
- 90% of the Board's primary classes with 20 or fewer students
- 10% of the Board's primary classes up to a maximum of 23 students
- Grade 3/4 classes have a cap of 23 students
 Junior/Intermediate Class Size Average for the Board is 24.5 students
