Director of Education Sovran provided some highlights and good news items that recognizes Upper Grand DSB students and staff that took place across Upper Grand DSB.

Upper Grand Teacher Wins Prestigious Award

Congratulations to John F. Ross teacher Erin Doupe, who was named the recipient of the Governor General's History Award for Teaching Excellence. The award recognizes teachers who strive for excellence in teaching Canadian history. Erin recently attended a ceremony in Ottawa where she received her award and was recognized by the Members of Parliament. Erin led her high school students through a local history project called The Story of a Soldier, which centred on the experiences of Guelph's soldiers and their families during the First World War. The students worked closely with attestation records, diaries, historical newspapers, and secondary sources which they used to craft a short biography of a soldier. The students then mailed their stories to the soldiers' last known address. The project took over five years to complete, and over 200 students were part of the undertaking to document and share the lives of Guelph's World War I deceased. Prior to the **Initial** Organizational Meeting, Trustees may be asked to identify their committee assignment preferences. Based upon the Trustee preferences and balancing workload and interests, a proposed roster of committee assignments shall be presented to the Board for approval.

Once the roster of committee assignments has been approved, the election of Standing Committee Chairs shall be conducted.

Standing Committees may, at their discretion, recommend the election of a Vice-Chair of the Committee, at a subsequent Board meeting.

In the event of the Standing Committee Chair becoming vacant for any reason, a new Chair shall be elected in the same manner as before provided.

4.1.7 Term of Office

The term of office for all Chair, Vice-Chair, **Members** and Standing Committee

Address - Chair of the Board

I'll keep my remarks brief.

I'd like to thank my trustee colleagues for their support and confidence in both me and our ability bring our voices together and make the best decisions for the system.

Before the meeting, I took a quick look at what I said a year ago – I said that we have some big tasks ahead of us. For me, in retrospect, the biggest task was unspoken. That was my own learning and growth, learning not just about procedural bylaws and formal meeting procedures and the roles and responsibilities of the trustee and chair role, but learning a something about each of you, my colleagues. I hope I have been able to turn this into an opportunity, an opportunity to best ensure all our strengths and interests, community connections and lived experiences are brought to the table to allow us to make the best decision possible.
