## Long Term Accommodation Plan (LTAP) - Final Report

The Long Term Accommodation Plan (LTAP) - Final Report was presented for consideration by the Finance and Facilities Committee. The report contained a review of accommodation tools used by school boards to align facility spaces to school board requirements. The report also included an extensive review of enrolment patterns regarding each planning area of the school board. Discussion took place regarding the changes in Provincial Policies that followed the presentation of the Draft LTAP Report and how the impact of these polices impacted the timing of the Final Report. The communication strategy related to the LTAP was also discussed.

# Capital Projects Update

A verbal report was provided regarding the new South Guelph Secondary School and the new Centre Wellington Elementary School. Submissions in response to the tender for the new Centre Wellington Elementary School were to be received on March 20, 2024.

Approval to proceed forms are under review by the Ministry of Education for the new South Guelph Secondary School. Staff are also continuing to work with the City of Guelph for site plan approval. Construction for both schools is targeted for this spring pending Ministry and municipal approvals.

## Electric Vehicles Information

An update was provided regarding Electric Vehicles for the school board's fleet of vehicles. Discussion took place regarding the process for calculating baseline emission metrics for the school board's vehicles. The baseline metrics are based upon the distance travelled by the vehicles, the fuel used and the approximate amount of cardon dioxide produced by a litre of gasoline (as per Natural Resources Canada). This baseline information will help in evaluation of sustainability strategies related to the fleet of vehicles.
